WAIVER AND RELEASE OF LIABILITY

I also assume full responsibility for all claims of bodily injury or physical or property damage done by me, any family member, spectator or guest accompanying me, or any horse owned by me or any family member, spectator or guest accompanying me, and I indemnify and hold harmless NEMAHC, its member club and affiliates described above with respect to all such claims.

I acknowledge this event occurs on grounds or in buildings leased by NEMAHC or its member club for this scheduled event only, and that NEMAHC or its member club have no responsibility or control over the condition or maintenance of the grounds or buildings.

If I am a member of NEMAHC, this waiver and release of liability does not supersede the one I signed with my application for membership but instead affirms that I, as an exhibitor or guardian of an exhibitor, agree to and confirm the terms of my original waiver on this date and any future date that I participate in a NEMAHC horse show or event. Finally, I confirm that I have sustained no physical injury or personal or property damage during this event but before the date of my signature.
